Extension of Disaster Declaration

Motion by Mike Richardson, seconded by Larry Leaming to extend resolution 20-02 continuation of declaration of local disaster emergency. Motion carried unanimously.

NEW BUSINESS

2nd Review of Proposed Salary Range Updates

Chief Wolf presented to the board the proposed salary range updates. No changes since it was presented at the last board meeting.

Motion by Dave Hamrick, seconded by Jon Hodde to approve the salary range updates as written. Motion carried unanimously.

2nd Review of Proposed Changes to Prevention Fee Schedule/ Resolution 2020-07

Chief Wolf presented to the board proposed updates to the plan review and inspection fee schedule. Since the last meeting there was a minor change to section 1A of the illegal burning to change from 15 feet or less to 15 feet or more. The fee schedule for illegal burning was approved by our lawyers for inclusion. Dave Hamrick noted that the description for gate installation did not match for gate installation.

Motion by Larry Leaming, seconded by Mike Richardson to approve resolution 2020-07 prevention fee schedule with the correction to gate installation description. Motion carried unanimously.

Chief Wolf presented the proposed changes to the plan review fee waiver policy. There have been no updates since the 1st review.

Motion by Mike Richardson, seconded by Dave Hamrick to approve the updates to the plan review fee reduction/waiver policy. Motion carried unanimously.

Chief Wolf presented the proposed changes to the impact fee reduction/waiver policy impact fee waiver policy. There have been no updates since the 1st review.

Motion by Mike Richardson, seconded by Jon Hodde to approve the updates to the impact fee reduction/waiver policy. Motion carried unanimously.

Combined Resolution 2020-08 to Adopt the Budget & Appropriation of Funds

Chief Wolf presented to the board resolution 2020-08. No changes since the last review of the budget. One question was brought up by the board wondering about the timeline for new vehicle delivery.

Motion by Jon Hodde, seconded by Larry Leaming to approve resolution 2020-08 to adopt the budget & appropriation of funds. Motion carried unanimously.

Resolution 2020-09 to set Mill Levies

Chief Wolf presented to the board resolution 2020-09 to set the mill levies at 1.958 mills. Motion by Mike Richardson, seconded by Dave Hamrick to approve resolution 2020-09 as written. Motion carried unanimously.

2021 Meeting dates & Times

The notice for 2021 meeting dates and times was presented. There was no discussion of changes. Dates and times will remain the same, 2nd and 4th Wednesday of the month at 5:30pm. Motion by Dave Hamrick, seconded by Mike Richardson to approve the 2021 meeting dates and times. Motion carried unanimously.


